Our Baseline deviates from the requirements under PPN 06/21 as follows:

- Scope 3: Category 4: Upstream transportation & distribution: is not included as transportation and distribution recharged to customer.
- Scope 3: Category 1: Purchased goods and services: is included as Water for bathrooms and kitchens. Scope 3: Category 3: Fuel and energy related activities: is included as Well to tank emissions included for completeness.



We project that carbon emissions will decrease over the next five years to 869.8 tCO2e by 2028. This is a reduction of  $18.5\,\%$

#### **Completed Carbon Reduction Initiatives**

#### **Future Carbon Reduction Initiatives**

In the future we hope to implement further measures such as:

- Calculate our full carbon footprint including scope 3 value chain emissions
- Reduce non-essential travel by increasing online meetings, travel by train rather than plane where possible
- Reduce Downstream Transportation & Distribution by encouraging customers to source locally to decrease shipping emissions
- Further exploration of tree planting programmes
