

Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 936.4 tCO2e by 2028. This is a reduction of $18.5\,\%$

Progress against these targets can be seen in the chart below:



The increase for the year was expected as a result of the immediate pandemic bounce-back.

The following environmental management measures and projects have been completed or implemented since the 2023 baseline and the measures will be in effect when performing the contract.

- 14001 compliant (2025 health check audit, March 2026 recert)
- Main UK Shiping partner (Ingram Micro) relocated site to EPC A+ building
- Reduced air travel by 30%
- Reduced electricity by 19%
- All partners are zero landfill and dispose responsibly

Future Carbon Reduction Initiatives

In the future we hope to implement further measures such as:

- Engage top 10 suppliers to get Net Zero targets in place
- Calculate our full carbon footprint including scope 3 value chain emissions
- Reduce Downstream Transportation & Distribution by encouraging customers to source locally to decrease shipping emissions
- Further investigation of digital rewards instead of physical products
